

# "Score with Genome" Campaign Terms & Conditions

## 1. Introduction

Welcome to the **"Score with Genome"** campaign (hereinafter - Contest)! These T&Cs outline the rules and regulations for participating in the Contest organized by UAB Maneuver LT (Genome). By participating in this Contest, you agree to comply with these terms and conditions.

## 2. Eligibility

2.1. The Contest is open to all businesses eligible for international money transfers whose representatives open a business account with Genome and fulfill the requirements during the Contest period. Please check the [international transfers availability page](#) to find out which supported countries and industries are eligible for these types of payments.

2.2. Employees of Genome, their family members, and anyone else connected in any way with the Contest or helping to set up the Contest shall not be permitted to enter.

2.3. Participants must ensure that their business account is verified and active to qualify for the Contest.

## 3. Contest period

3.1. The Contest starts on July 2, 2024, 00:00 (GMT+3) and ends on July 28, 2024, 23:59 (GMT+3). Entries submitted before or after this period will not be considered.

## 4. How to enter

4.1. To enter the Contest, participants must:

- Open or have a business account with Genome.
- Complete the account verification process.
- Request account details to make global payments.
- Make at least 1 transfer in a currency other than the Euro for 1,000 EUR and more.

4.2. There is no limit to the number or amount of money transfers per participant - the more qualifying transfers are made, the more chances to win.

## 5. Selection of winner

5.1. The winner will be selected through a random draw service lottery draw from all eligible entries.

5.2. The draw will be conducted on July 29, 2024, and the winner will be notified via email the same day.

5.3. If the winner cannot be contacted or does not claim the prize within 2 business days of notification, we reserve the right to withdraw the prize and select a replacement winner.

5.4. If it is not possible to contact the winner until August 2, 2024, or the winner refuses the won prize, in this case, it is considered that the Contest has taken place properly, but there is no winner, and the prize remains undelivered.

## 6. Prize

6.1. The prize consists of 2 tickets to the Men's Basketball Final at the Paris Olympics on August 10, 2024.

6.2. The prize includes only the tickets to the game mentioned above. Any other expenses, such as travel and accommodation, are the responsibility of the winner.

6.3. The prize is non-transferable, non-refundable, and cannot be exchanged for cash or other alternatives.

## 7. Personal Data Processing and Privacy

7.1. Data collection: By entering the Contest, participants agree to the collection, use, and sharing of their personal data, including but not limited to the company name, representative name, contact information, and any other information provided during the Contest entry process.

7.2. Purpose of data processing: The collected data will be used for the purpose of administering the Contest, publicizing the winner on social networks (publicly announcing the name of the company), including determining and contacting the winners, and for any other purposes outlined in these terms and conditions.

7.3. Data storage and security: All personal data will be stored securely, and appropriate measures will be taken to protect the data from unauthorized access, disclosure, alteration, or destruction.

7.4. Data sharing: Personal data may be shared with third-party service providers who assist in the administration of the Contest or to help us duly select the winner as specified in these terms and conditions. These third parties are bound by confidentiality obligations and are only permitted to use the data for the purposes specified in this paragraph.

7.5. Rights of participants: Participants have the right to access, correct, or request deletion of their personal data. Any such requests should be directed to our data protection officer by email: [dpo@genome.eu](mailto:dpo@genome.eu).

7.6. Retention period: personal data will be retained only for as long as necessary to fulfill the purposes outlined in these terms and conditions and to comply with any legal obligations.

8.2. Genome will notify participants of any changes to the Contest as soon as possible.

8.3. By entering this Contest, participants agree to the use of their business name and wallet ID in any publicity material, as well as their entry. Any personal data relating to the winner or any other participants will be used solely in accordance with Lithuania's data protection legislation and the procedure described in these terms and conditions.

## 9. Limitation of liability

9.1. Genome accepts no responsibility for entries not received for whatever reason.

9.2. Genome is not responsible for inaccurate prize details supplied to any entrant by any third party connected with this Contest.

9.3. In the event of any dispute regarding the rules, conduct, results, and all other matters relating to the Contest, Genome's decision shall be final, and no correspondence or discussion shall be entered into.
